Reservations on Appendices I and II

1. The Depositary Government (Government of Switzerland) has informed the Secretariat that in relation to Article XV, paragraph 3, of the Convention, the following reservations were entered with respect to the amendments to Appendices I and II adopted at the 17th meeting of the Conference of the Parties (CoP17, Johannesburg, 2016):

^{*} Although these reservations were received after the deadline set out in the Convention, the Depositary Government has indicated that in keeping with the practice followed by other depositaries in similar cases, it intends to consider these reservation as received, if there is no objection from any CITES Party by 24 April 2017.

- 2. Indonesia's reservation on the inclusion of *Dalbergia* spp. in Appendix II, is made until 4 July 2017 and will therefore be considered as withdrawn automatically as from 5 July 2017.
- 3. Notice of these reservations was communicated officially to the signatory and acceding States to the Convention through a Notification from the Depositary Government.
- 4. The above-listed reservations were all effective from 2 January 2017, the date on which the amendments to the CITES Appendices adopted at CoP17 entered into force with the exception of those indicated with an asterisk (*), which will only enter into force on 24 April 2017, provided that no objections are received by the Depositary Government.

6. The Secretariat has exchanged letters with the Depositary Government regarding the practice of receiving late reservations under certain conditions. This practice is to propose to the Parties to receive late reservations for deposit in the absence of any objection on the part of any of the Parties within a given deadline, either to the deposit itself or to the procedure envisaged. The Secretariat, in consultation with the Depositary Government, will bring this issue to the attention of the Standing Committee at its next meeting to seek clarification.
